President's Corner

"Now and then we had a hope that if we lived and were good, God would permit us to be Pirates." Mark Twain.

Just off the coast of Hutchinson Island is Gilbert's Bar. This is a sand bar named after the pirate Pedro Gilbert, who would use the sand bar to chase cargo ships and cause them to run aground on the bar and steal whatever cargo they were carrying.

Said to be the last American pirate, Pedro Gilbert was actually a South American born pirate who made his home in South Florida. It is said that Gilbert and his pirate gang of twelve would wait for passing ships. They would then chase the ship. With the Captain of the fleeing vessel not familiar with the area, they would be an easy catch on the sand bar.



In 1832, one such ship, known as the "Mexican," fell victim to the pirate.

During the attack, the pirates stole roughly \$20,000 worth of silver from the ship. Gilbert ordered his men to kill everyone on board and burn the ship.

Instead, the crew decided to lock everyone below the deck and let them burn alive.

Once the pirates had fled the scene, the captain of the Mexican was able to free himself and then his sailors. They put out most of the fire, but kept part of it going, for fear the pirates would see the flames die out and return to finish the job.

The crew of the Mexican survived, and after several weeks at sea, managed to sail back to their original port.

It was then that Gilbert's crimes were reported, leading to a massive search for the pirates. Pedro Gilbert's ship and all twelve men (thirteen counting Gilbert himself) were found off the coast of Africa, loading slaves, by the British Navy in 1833.

The British captured the men and blew up their ship, the Panda. Gilbert and his crewmen were extradited to Boston for trial.

In 1834, all thirteen men were convicted of piracy charges, and were hung in the spring of 1835.

As President of the largest PAC of Accreditation Pirates in the Nation, I am proud to say we have not experienced any hangings in our twenty years of existence. We sail out to our on-site and mock excursions with the best of intentions, then we pilfer and plunder through the agency's policy and procedures, looking for any loot or booty to take back to our own ships.



Captain Scott Bierwiler

Hernando County Sheriff's Office

Captain Bierwiler, a 23 year veteran of the Hernando County Sheriff's Office, was killed on February 19, 2009, when his patrol car was struck head-on by a teenage driver near Brooksville, Florida.





Corrections Officer Adam Sanderson

Florida Department of Corrections

Corrections Officer Adam Sanderson, a 10 year veteran of the Florida Department of Corrections, was killed on March 6, 2009, when the van he was driving as part of a mock escape drill was struck head-on by a suspect fleeing the scene of a stabbing in Union County, Florida.





Corrections Officer Mark Parker

Orange County Sheriff's Office

Corrections Officer Mark Parker succumbed to gunshot wounds sustained on January 10, 1984, in the Orange County Courthouse, while shielding citizens from a gunman. Officer Parker was a one-year veteran of the Orange County Department of Corrections and was 19 years old at the time of the shooting.

Deputy Sheriff Warren (Skip) York

Okaloosa County Sheriff's Office

Deputy York, a two year veteran of the Okaloosa County Sheriff's Office, was killed by gunfire on April 25, 2009, while attempting to arrest a suspect for domestic violence. Also killed in this incident was Deputy Sheriff Burt Lopez.

Okaloosa County Sheriff's Office

Deputy Lopez, a six year veteran of the Okaloosa County Sheriff's Office, was killed by gunfire on April 25, 2009. Deputy Lopez and Deputy Warren "Skip" York were killed while attempting to arrest a suspect for domestic violence.





Police Officer Giovanni Gonzalez

Miami-Dade Police Department

Officer Gonzalez was killed on June 16, 2009, when his patrol car collided with a dump truck on Florida's Turnpike. Officer Gonzalez was a one-year veteran of the Miami-Dade Police Department.





Corporal Mike Roberts

Tampa Police Department

Corporal Roberts, an 11 year veteran of the Tampa Police Department, was killed on August 19, 2009. Corporal Roberts was investigating a suspicious person in the Sulphur Springs area of Tampa when he was shot.





Detention Sergeant Ronnie Brown

Polk County Sheriff's Office

Detention Sergeant Brown succumbed to injuries sustained while conducting a cell extraction at the South County Jail in Polk County. He was a 20 year veteran of the Polk County Sheriff's Office.

Certified Accreditation Professional Program



The Certified Accreditation Professional Program (CAP) was established by the FLA-PAC Executive Board at the June, 2009 conference

The certification focuses exclusively on the individual and is an indication of current proficiency in a particular criminal justice field. Accreditation professionals who become CAP designees will be distinguished as individuals who have reached one of the highest levels of achievement and recognition in their field.

Mandatory Requirements

- Candidates must be employed by a member agency of FLA-PAC or must be an associate/retired member of the FLA-PAC.
- Candidates must be currently active in the FLA-PAC
- A total of 650 points must be earned across four (4) categories:
 - Experience,
 - Education and Training,
 - Leadership and Services,
 - Awards and Recognition
- Attendance at one (1) FLA-PAC Conference <u>including the FLA-PAC Business Meeting</u> per year is required

Submission

Candidates must submit a COMPLETE application package with all documentation to verify eligibility. Incomplete application packages will not be reviewed and will be returned; the CAP Committee will not maintain incomplete application packages.

Application packages must be submitted to the CAP Committee Chair no later than six (6) weeks prior to each conference.

The following documentation must be submitted with the application package:

- Proof of continuous assignment to accreditation activities (letter from CEO; Facility Administrator; Human Resources Director, etc.).
- Proof that the candidate's agency was accredited/reaccredited while candidate was assigned to accreditation activities (copy of certificate, letter from CEO or appropriate agency official, CFA/FCAC notification, etc).
- Documentation of assessor/team leader activity.
- Proof of education/training completed.
- Documentation of leadership and service activities.
- Proof of awards/recognition received.

The deadline for submission of packets for the June, 2010 conference is **May 28, 2010.**

Domestic Marijuana Eradication

Florida's DME Program is a federally funded system which directly supports local, state, and county law enforcement agencies in the detection, dismantling and eradication of domestically grown marijuana. The DME Program is jointly administered by the United States Drug Enforcement Administration's (DEA) Domestic Cannabis Eradication/Suppression Program (DCE/SP), the Office of Agricultural Law Enforcement (AgLaw) and the Florida National Guard (FNG).



AgLaw joined this program in 2005 and has been responsible for the coordination of all outdoor grow investigations in Florida. Effective January 2008, AgLaw assumed responsibility for administering the indoor grow program, previously administered by the Florida Department of Law Enforcement.

Participation in this program allows local law enforcement agencies to be eligible for funding to help offset the costs associated with marijuana eradication. To participate, agencies must submit a DME Field Summary detailing the marijuana eradication mission, and submit an accompanying Reimbursement Request Form. Funds are dispersed based upon the number of plants eradicated in accordance with the Reimbursement Matrix. These forms can be found on AgLaw's website at http://www.fl-aglaw.com/bas/dme.html.

In addition, the program provides free training opportunities for all Florida law enforcement officers. Each year, an Indoor Cannabis Investigation School and an Outdoor Investigation/Spotter School is scheduled. Information regarding these schools can be found on the above listed website.
